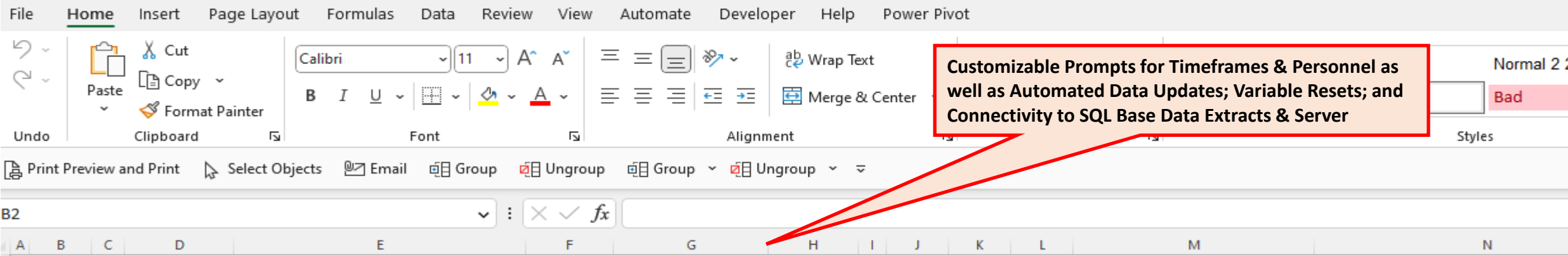

You make your report selection prompt choices and then you press the "Go" button. The report will automatically update based on the selections.
